You can change your choice at any time by notifying us in writing. In the case of notices of meeting your notice can be a standing one or relate only to a specified meeting. Collection of personal information

GoodLoop Mutual Limited (GoodLoop) collects your personal information for the purpose of processing your application for membership and the maintenance of a register of members as required by the provisions of the Corporations Act 2001. We may also use the information to send you information where you have elected to receive material from us, or you wish to access any other products and services we provide. If you provide incomplete or incorrect information, we may not be able to provide you with the product or service you are applying for.

Use and disclosure of your personal information

We may use your personal information to perform our business functions (for example internal audit, operational risk, product development and planning).

We treat your personal information as confidential and only disclose it to others where necessary. For example, we may disclose your information to organisations to whom we outsource functions such as mailing and printing houses, IT providers, our agents and specialist advisers such as accountants and solicitors. But where we do so we will either take reasonable steps to ensure that it complies with Australian privacy laws or we will seek your consent to the disclosure.
